# What is the National Coronial Information System?

The National Coronial Information System (NCIS) is a secure database of information on all deaths reported to a coroner in Australia and New Zealand.

NCIS data supports research projects, policy development and death investigation carried out by organisations working towards reducing preventable death and injury.

# The coronial process

The coroner's role is to independently investigate reportable deaths in accordance with the relevant Coroners Act.


Coroners aim to determine the identity of the deceased and the cause and manner of death. In addition, they may make recommendations aimed at addressing public health and safety issues and preventing future deaths. Further information is available on the **Coroners Courts' websites**.

#### Reportable deaths



The NCIS is a research database that enables information sharing among those who work in the death and injury prevention sector. The NCIS does not form part of the formal coronial process.

### About the data



The NCIS data collection consists of coded fields and investigative reports about every death reported to a coroner in Australia and New Zealand - around 12% of deaths annually.

The data includes demographic information, cause and manner of death, intent, circumstances, contributing external factors and searchable medico-legal reports.

Data is available for all Australian states and territories (except Queensland) from 1 July 2000. Queensland data is available from 1 January 2001 and New Zealand data from 1 July 2007.


# **Data quality**

Data is securely uploaded to the NCIS from all coronial jurisdictions in Australia and New Zealand, with coding performed by staff in the coroners courts.

The NCIS Unit undertakes initial data validation to ensure the data's consistency and compliance, and reviews cases to ensure high quality standards.

The NCIS Unit regularly reports on data quality, administers coding structures and provides training and feedback to coding staff in the jurisdictions.

# **Accessing NCIS data**

There are two avenues through which eligible organisations may access NCIS data - direct access and data reports.



### **Direct access to the NCIS**

Direct system access to the NCIS is available for authorised users, allowing them to view coronial case information via a secure online interface.

Applicants must have a bona fide interest or professional role in public health and safety or a statutory requirement to collect and publish data.

The following parties may be eligible to apply for access:

- **Death investigators** users with a role in the coronial investigation process
- Third party researchers users with an ethically approved research project

### NCIS data report service

NCIS data reports provide aggregate, statistical information and may include deidentified case summaries.

The NCIS Unit assesses requests based on the following criteria:

- Request is received from an organisation with a bona fide interest in death and injury prevention
- Intended use of data will meaningfully contribute to death and injury prevention
- Data will not be used for personal or legal purposes

All data reports require approval from the relevant State or Chief Coroner(s) prior to release.

### **NCIS** fact sheets

**NCIS fact sheets** provide de-identified statistics outlining mortality trends and issues in response to community interest and safety concerns. There are three suites of fact sheets:

- Mortality data series deaths due to injury, drug contribution and intentional self-harm on a calendar year basis
- Intentional self-harm series deaths among specific populations, including by age, occupation and ethnicity
- Common interest topics deaths based on other categories of interest, including sport and recreation, animal and drug-related

### **Fatal facts**

**Fatal facts** is a unique source of case summaries and findings for deaths reported in Australia where coronial recommendations have been made.

The Fatal facts search tool can be searched by year, jurisdiction and category - such as law enforcement, mental health, aged care, work-related and transport incidents - to identify cases of interest.

The search tool is regularly updated with recently closed cases.

# Research publications and reports
