Dr. Tanya Bell BAppSc (Biol)(Hons) GCEd (HE) PhD (PHE), is a Population Health Epidemiologist with a passion for improving community health and well-being by translating evidence-based health care into practice. Tanya is an accomplished leader with over two decades experience in research and academic institutes, government and non-government agencies including Medical Locals and Primary Health Networks.

Tanya's engagement with the suicide prevention sector began during her time at ConNectica, an Australian social enterprise and a trusted national and international thought leader in mental health, suicide prevention and human services. As a peer reviewed published researcher, Tanya has been commissioned to complete reviews and analyses of mental health services, people's lived experiences and suicide prevention strategies plans. She was a key author in the National Mental Health Commission's Review into the Suicide and Self-Harm Prevention services of current and former serving Australian Defence Force members and their families.

Nominee Education & Experience

After losing five friends to suicide back in 2016, I immersed myself to educate myself on mental health by unlearning all the stigmatic beliefs around mental health, eg men don't cry, you don't talk about your problems, etc. The more I learned, the more I wanted to be involved on an ongoing basis as I had this belief that while I may never fully help someone who's struggling with cancer, by unlearning this stigma on mental health I could perhaps make a difference to someone needing true connection while they struggled with mental health issues. While my 35+ years professional background was in global finance and investments, I left my career in finance, and with the generous help from others, had formed PROP. Unlike the many highly effective suicide awareness groups, PROPs goal is to help such groups within SPAs membership universe. In finance, there's no such thing as "seven degrees of separation"; at best there are three to four degrees. And working with others more knowledgeable, we funded and created a web page to help others follow my personal path of unlearning the stigmatic beliefs. I have worked exclusively with chronically suicidal patients in public mental health sector for over 30 years and I would bring 'on the ground' practical experience in suicide prevention. I have some insights in to what does and what doesn't work in suicide prevention in mental health clinical settings.

I have extensive clinical experience in suicidology and have researched and published scientific



papers in the field (papers on coronial suicide data, risk evaluation protocols that were incorporated in to the NHMRC Clinical practice guidelines for personality disorders, etc.).

I have collaborated with consumers and carers and helped build the BPD Foundation through which we have developed a National Consensus Statement for care of people with personality disorders across Australia.

I am passionate about suicide prevention and I believe it is possible with concerted effort. I have developed models of care for people with personality disorders and complex trauma.

Nominee Education & Experience

I am a Senior Research Fellow, mental health researcher, focused on suicide and self-harm prevention. I completed my PhD in the School of Medicine, The University of Sydney, in 2015. I currently work for University of Sydney and am a visitor and adjunct at The University of Western Australia, School of Population and Global Health. I have established my postdoctoral research in detecting opportunities for self-harm and suicide prevention from a public health perspective, using big data and epidemiological methods. I received a National Health and Medical Research Council fellowship to support this research and my study, the Australian Suicide Prevention Using Health Linked data (ASHLi) study, is the largest population-based case series study of people who have died from suicide that has ever been conducted in Australia. As lead investigator of the ASHLi study I have had much experience successfully chairing meetings with, and presenting to, a wide variety of stakeholders about the topic of suicide. Often, I will present results from our study and spearhead the discussions around interpretation and future directions. Over the past year I have been consulting and collaborating with the World Health Organisation providing comments on drafts of suicide prevention initiatives delivered throughout the world.

Statement of Interest

I wish to be Director, first and foremost, because suicide prevention is a topic of utmost importance to me, as evidenced from the last 7 years of my research career. Directorship represents a significant opportunity for me to utilise my research skills and academic knowledge of suicide prevention in a directly translatable manner, which I believe will be a huge benefit to Suicide Prevention Australia and myself. Throughout my research career I have developed a wide and growing network of stakeholders in suicide prevention in Australia and internationally, and access to this will be a huge benefit to the Company. As an individual, I come from a place of empathy in all my interactions, professional or otherwise, and to this role I will bring commitment, dedication and my perspective as a woman, a mother, a wife, a sister, a friend, a cousin and a daughter.

Nicolas Brown has spent a large portion of his career in the for-purpose sector working with young people in Australia and overseas. In 2015 he began work at SPA Member organisation batyr.
